UPDATED GHOST RULE



Bylaw 26. Ghost Rule: There may be times when teams may not have enough available players to field a full roster of 5 players. A player's presence does not necessarily mean that the player is available since that player may not be available due to other potential obligations or maintaining the 23 rule. The ghost rule allows for the opposing team to choose any one of the available players to play an additional game as long as that player does not put the team over the 23 rule. Therefore, all players must remain available for the match being played as a ghost. If the opposing team chooses a player that played and is no longer available then the match will be forfeited. The team using the ghost rule must declare that they may be using the ghost rule before the first match is started. They also must declare which players are available, which ones are not available and which ones may potentially become available. The ghost rule can only be used during weekly scheduled play and cannot be used during playoffs or post season tournaments. Teams must have at least three players in order to use the ghost rule.

TIPS AND TRICKS

Becoming a consistent pool player begins with sound fundamentals. A solid stance is essential for accuracy. Position your two feet and bridge hand to form a tripod. Your feet should be spread apart and positioned to form a triangle with your bridge hand. The best way to test the stability of your stance is to have a friend give you a little push. If you lose your balance then you may want to reposition your feet.
