We have a new division starting in the Gloucester area. If you know anyone who is interest please let us know.

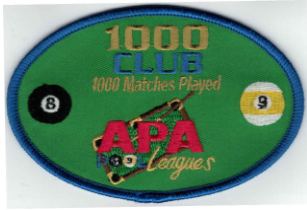
