Loser is eliminated

Division Finals and 3rd place finals: held at Claddagh May 21st and May 22nd

Winner of division finals, loser of division finals and winner of 3rd place all advance to Tri-Cup

Loser of 3rd place match advances to second chance tournament.

Second Chance Tournament:

8-Ball Second Chance will be held at Claddagh on Jun 4th and 5th

9-Ball Second Chance will be held at Claddagh on May 21st and 22nd

There will be 2 boards for 9-ball and 3 boards for 8-Ball in second chance tournament. Winner of each board will advance to Tri-Cups

Tri-Cup:

8-Ball Tri-Cup will be held at Claddagh on Jun 11th and 12th

9-Ball Tri-Cup will be held at Claddagh on Jun 5th

There will be 3 Tri-Cup Boards for 9-Ball and 5 Tri-Cup boards for 8-Ball.
